## Do you have under 500 employees?

- **HR 6201: Families First Coronavirus Response Act** was enacted 3/18/20. It applies to businesses with under 500 employees (certain exceptions are being decided) and establishes new rules and mandates around employee emergency paid sick leave, family medical leave, and tax credits for paid family and medical leave.

## Have you had to reduce employee hours or temporarily lay off employees?

- **EDD Work Sharing Unemployment Insurance (UI) Program** allows for payment of UI benefits to individuals whose wages and hours have been reduced. It is considered a temporary and practical alternative to layoffs, allowing you to retain your quality employees, while reducing your payroll burden and allowing them to supplement their wages during this time.
